- 2. Review and consider approval of minutes of the July 25, 2024, Board of Directors meeting;
- 3. Consider status of security patrol of parks and contract patrol services from the Harris County Sheriff's Office ("HCSO"), and the taking any actions required in connection therewith;
- 4. Consider matters related to the District's \$14,000,000 Unlimited Tax Bonds, Series 2024 (the "Series 2024 Bonds"), including:
 - a) Consider approval of report relative to payment of proceeds of the District's Series 2024 Bonds, and consider authorizing disbursement of Bond proceeds in accordance with same;
 - b) Consider review, approval and authorizing the filing of Internal Revenue Service Form 8038-G relative to the Bonds;
